#### **Criteria and Rules for Photo Submission:**

- · Contest is open to the general public (tell your friends!).
- Photographs must have been taken at one of our preserves (see our website for a full list of preserves).
- A maximum of up to 3 photos per entrant are allowed.
- You must submit your photo in the proper age category: Adult Contest (ages 17+) or Youth Contest (ages 1-16).
- Please respect wildlife and follow ethical wildlife photography practices. (See <a href="https://www.nathab.com/blog/10-tips-for-ethical-wildlife-photography/">https://www.nathab.com/blog/10-tips-for-ethical-wildlife-photography/</a>)
- Each photo submission must include a signed Contest Entry Form and Photo Release Form (included at the end of this document).
- Employees or board members of CNYLT are expressly prohibited from entering.
- CNYLT reserves the right to disqualify any submission, that in the sole judgment of CNYLT is inappropriate, in poor taste, or that may have the appearance of being forged, copied, stolen, illegal or contains illegal content or is otherwise suspect.

#### Photos will be judged on:

- Photographic quality
- Scenic or artistic beauty
- Photos that are conducive to CNYLT's marketing objectives. Ideal photos may include: wildlife, landscapes, drone photography, people enjoying our preserves!
- CNYLT will convene a panel of judges. These judges must disclose if they have an interest in
  or relationship with any applicant or photo. In the case of any actual or perceived relationship
  which may create a conflict of interest, CNYLT will require a judge to excuse themselves from
  voting on that particular photo.
- The judges are not "professional judges" of photography. The decision of the judges is final.
